Achievements and performance Summary of the main achievements of Although the financial year 2019/20 ended under the shadow of the the charity during the financial period COVID-19 pandemic and its associated restrictions on everyday life, it was a highly successful one for the Charity, both artistically and financially. There were two significant changes to the structure and operation of the Charity during the year, both aimed at creating a more modern, inclusive and resilient organisation. Firstly, the former Unincorporated Association (Music in Peebles) was converted to a Scottish Charitable Incorporated Organisation (Music in Peebles SCIO), with a new Constitution and greater financial safeguards for its Charity Trustees. This process was completed with the transfer of assets and winding up of the old charity in September 2019. Secondly, the concept of 'membership', with the attendant perception of exclusivity, has been removed and replaced with a subscription model, offering discounted season tickets which are available to all. These season tickets are sold by the box office at our venue, giving purchasers a more accessible, streamlined process and greater flexibility of payment method, and removing from the Charity the administration associated with mass membership. As a single-tier SCIO, the new organisation has only its Trustees as Members. These changes have been well received by the Charity's supporters. Due to over-running refurbishment work at our regular venue, it was unavailable for the opening concert of the 2019/20 season. However, this risk had been anticipated by the Trustees and our contingency plan to use an alternative venue was effective, allowing a very successful concert to proceed. At the other end of the season, it was sadly cut short by the closure of the Eastgate Theatre due to prohibition of public gatherings, resulting in the cancellation of our final concert. However, the seven remaining public concerts provided audiences, largely drawn from Peebles and surrounding communities, with live chamber music of an exceptional standard. Our artists included the world-renowned Fitzwilliam String Quartet, tenor James Gilchrist, pianist Yu Kosuge and rising star pianist Florian Mitrea. We were also delighted that our illustrious patron, Gina McCormack, presented another Young Musicians' Showcase, which we plan to be a regular feature of our season, providing a platform for students and alumni of the Royal Conservatoire of Scotland. Average attendance for the season remained steady at 144 and artistic standards reached new heights, with average audience ratings of 4.81 out of 5, the highest we have ever recorded. Our outreach programme, generously supported by local businesses and a local charitable trust, saw two highly enjoyable performances in our local residential care home and an education workshop in a local primary school. Sadly, four further planned outreach events had to be cancelled due to the coronavirus pandemic. In addition to the Charity's own fundraising efforts, and the financial support referred to above, the Trustees are very grateful to Chamber Music Scotland for providing a grant of £2,800 in support of our concert series. The season was successful financially, with an operating surplus

series. The season was successful financially, with an operating surplus of \pounds 4,114 and a growth in the Piano Fund (a restricted fund) of \pounds 1,233, bringing it close to its initial target of \pounds 20,000. Our general (unrestricted) funds now have a balance of over \pounds 7,000, which provides a vital cushion in safeguarding the sustainability of the Charity in the uncertain times ahead.
