Data Processor	 Music in Peebles has the right to: receive subscribers' personal data from the Eastgate Theatre under the terms of this Agreement; use such data to maintain a list of subscribers for the purposes of sending out season ticket renewal notices, newsletters and other communications relating to Music in Peebles activities; otherwise use such data in accordance with its Privacy Notice which is available at https://musicinpeebles.org.uk. 			
Data Subjects	Data subjects have the right to unsubscribe from communication from Music in Peebles and to request that their personal data is deleted. They also have the right to submit a Subject Access Request and to have this handled as set out in Section 5.			
Section 5 – What if something goes wrong?				
Data Breach	Eastgate Theatre and Music in Peebles will take all reasonable steps to ensure personal data is not lost, destroyed, corrupted or stolen. In the event of any breach of data security, Eastgate Theatre and Music in Peebles will inform the data subjects impacted at the earliest opportunity and will work together, and with any relevant external agencies, to investigate and address any security issues.
